### Creating a meet in GymJas

GymJas is the Judges Assigning System used by the NAWGJ, which is the governing body for USAG WAG Judges. Many states and State Judging Directors (SJD's) prefer all meets to be placed into this system for judging assignments. However, this system is not universal, and some states may have different processes. If you are part of a state that does not use this GymJas setup, please look for more information under your state <a href="here">here</a>. 1. Go to gymjas.com. From there, choose the state that your meet is being hosted in. You may also need to repeat this process for other states if you need more judges from nearby states.
