

NAIGC Materials Copyrights Policy
Version 1.22 / Last Amended 12/14/2022

I. Purpose

A. The purpose of this document is to:

1. Clearly define all copyright rules which will apply to NAIGC materials; and
2. Explain what effect these rules will have on other parties.

II. Materials

A. Logo and Motto

1. The NAIGC motto, “For the Love of the Sport”, is trademarked (US Serial Number: 86573748 and US Registration Number: 5161684).
2. The NAIGC logo and motto may not be used or reproduced without the express permission of the NAIGC except as stipulated below.
3. The NAIGC logo and motto should not be modified in any way - wording, colors, fonts, aspect ratio, etc. should be unaltered. Acceptable logos and additional details can be found in the NAIGC Brand Standards.
4. Member clubs have permission to use the NAIGC logo and motto, consistent with the NAIGC’s Code of Conduct, under the following conditions:
 - a) Promotion of the NAIGC.
 - b) Promotion of the NAIGC member club.
 - c) Creation of meet-specific apparel for a meet hosted by the NAIGC member club.
5. NAIGC member club permission may be revoked by the NAIGC at any time.

1. All pictures and videos owned by the NAIGC are available under the GNU General Public License 3 unless otherwise stated above.
2. If any pictures or videos owned by the NAIGC are reproduced in any form, then an image/video credit is required in the form of either a text citation or a hyperlink to the original NAIGC source.

1. All hardware designs developed by the NAIGC are available under the GNU General Public License 3 unless otherwise stated above.

D. Printed Material

1. All printed material is available under the GNU Free Documentation License 1.3 unless otherwise stated above.

E. Website Content

1. All website content is available under the GNU Free Documentation License 1.3 unless otherwise stated above.

F. Wiki Content

1. All wiki content is available under the GNU Free Documentation License 1.3 unless otherwise stated above.
